MEMORANDUM OF UNDERSTANDING (MoU) FOR

This MoU is made and executed at Tiruchirapalli on this date of 1st January of the year 2020.

BETWEEN

The college is recognized under 2f and 12 B under UGC Act, 1956. Our Institution has been conferred with Autonomous status from the academic year 2019-20. This prestigious college aims for excellence in education wherein we have opened the portals to many first generation learners and students from rural areas to varied branches of study. The primary aim of the college is to nurture professional competency, self-confidence, managerial abilities and entrepreneurial development among students. NAAC has

awarded "A" Grade to the college consecutively in all the three cycles (I cycle A Grade, II Cycle A Grade with CGPA 3.37 and III Cycle A Grade with CGPA 3.41out of 4). The college is offering 15 Under Graduate Programmes, 10 Post Graduate Programmes and 6 Research Programmes with total student strength of 5096. Activities

- Share the library and scientific literature facilities mutually by giving access to library and other resources of either Institute to the scientists / students / research personnel of other Institute;
- 5. Encourage the research / graduate students of Cauvery College for Women (Autonomous) and scientific staff of K.S.Varier's Ashtanga Ayurvedics (P) Ltd to visit the other Institute for short durations for getting research inputs and guidance upon recommendation from the research guides/ faculty members of Cauvery College for Women (Autonomous) or Directors of K.S.Varier's Ashtanga Ayurvedics (P) Ltd;

Duration

The MoU is valid for a period of 24 months from the date of signing.

Termination

Either party is free to terminate the agreement by giving a notice of 1 month prior to termination.

Governing Law

The contract shall be governed by the Law of India for the time being in force.
