Responsibilities of Thinkin Lab

1. **At site course/online course for Entrepreneurship Development Cell - Thinkin Lab** is pleased to offer at site certification courses / online certification course in the domain of **Robotics, Python Programming, Artificial Intelligence, 3D Printing and Internet of Things (IoT), AR & VR Development or any topics based on requirement .**
2. **Internship for The College Students , Thinkin Lab** is pleased to take the students for internship based on students' performance and terms.
3. **External Projects Execution–** Projects can be taken in co-operation with Thinkin Lab and The College Students. Thinkin Lab employee will guide the project and accountable till the successful completion of the project. Project can be occurring either in college campus or Thinkin Lab
4. **Research Guidance:** Thinkin Lab will guide and give support to the faculties and students with our core computer science, physics and electronics domain based on the requirement.
5. **Conference & Workshop:** The College can organize conference and workshop in collaboration with Thinkin Lab.
6. **Special Lectures:** Thinkin Lab will give special lecture to both faculties and students at The College to update their level of skills.

Responsibilities of College

1. The College will provide necessary space and other infrastructures like Computers, Printers, UPS, furniture & fixtures, supporting facilities, video and audio, etc., at The College will have exclusive right to operate the Thinkin Lab inside the college campus subject to the terms of this agreement.
2. The College will ensure that each participating student has access to relevant hardware and software.
3. The College will permit to utilize their library facilities.
4. The College agrees to take up consultancy from Thinkin Lab and complete the task within the stipulated time.
5. The College undertakes not to forward or disclose any information concerning the specifics of this agreement to any third party without the prior written consent of Thinkin Lab
6. The College will not permit any practice that may be detrimental to the trademarks or

Force Majeure

No party shall be liable to the other if and to the extent, that the performance of any of its obligators under this agreement is prevented, restricted or interfered due to the circumstances beyond the reasonable control of such party including but not limited to Government Legislation, fire, flood, explosion, epidemics, pandemic, accidents, Act of God, wars, riots, strikes, lockouts or other connected acts of workmen and act of Government.

Terms of Agreement and Termination of Agreement

1. This agreement is effective from the date of signing by **Thinkin Lab** and shall be valid for a period of **two years (24 months)** from the date of the agreement. The parties may renew this agreement for further periods on mutually agreed terms.
2. Either party may terminate this agreement by giving not less than **3 months' notice** to the other party.
3. Notwithstanding the stipulation in above clause, each party is entitled to terminate this agreement immediately on any other party committing the breach, which is not insignificant and such party does not remedy such breach within 30 days from written notice by the other party requiring the default party to remedy the same.
4. In the event of termination of the agreement, for whatever reasons, both the parties agree to fulfill their respective commitments to the already registered batch of students as if the agreement is still in force.
5. On termination of this agreement, neither party will be entitled to claim any compensation or damages for or in respect of or by reason of such termination, except where such claim is based on the default of the other party.
6. Neither party will in any event be liable to the other party under this agreement for loss of profit, loss of business, loss of revenue or for any indirect, incidental or consequential damages whether or not the possibility of such damages could have been reasonably foreseen.

Arbitration

All disputes or differences whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect of this contract or the breach thereof shall be settled by arbitration with the Rules of Arbitration of the Indian Council of Arbitration at Vellore only and the award made in pursuance thereof shall be binding on the parties.


