- 2.4. The Center of Excellence setup for Quality Assurance, a Center of Excellence for Compliance, or a Center of Excellence for Customer Experience.
- 2.5. Build a Center of Excellence around new technologies such as intelligent automation, which completes business processes from end to end, and is available through the platform.
- 2.6. Invite key stakeholders within the companies to join the CoE; make sure they understand and agree on specific goals.
- 2.7. One of the major purposes of CoE is to get full stakeholder buy-in.
- 2.8. Integration with key business units by the CoE members from across the organization. Keep the CoE engaged; share information; create visibility; and make CoE members available to employees who have questions about the new initiative.

A. ROLES OF Cauvery College For Women, Tiruchirappalli

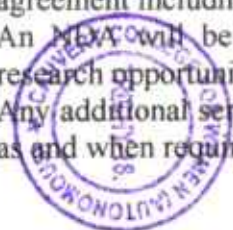
1. Provide/Setup the Lab and other facilities for conducting the advanced training programs to meet Centre of Excellence standard under the IT-ITeS sector.

B. ROLES OF SVASTI

1. Provide technical support, and help upgrading Centers of Excellence for automation and process improvement initiatives. Associate with **Cauvery College For Women, Tiruchirappalli** to build a CoE that will create best practices, define a governance model, identify Key Performance Indicators (KPIs), and measure the value of automation across the business lifecycle.

- 4.5. **Cauvery College For Women, Tiruchirappalli** agrees to set up the Lab facility based on the requirements.

5. TENURE & VALIDITY

5.1. This MoU is valid for the next FIVE Years starting from December 2023 to December 2027, subject to renewal of every year, unless terminated by either party in accordance with mutual understanding or as per the conditions mentioned in the termination clause.

6. TERMINATION

Termination on Notice. Either party may terminate this agreement for any reason on 90 Business Days' notice to the other party.

Termination for Material Breach. Each party may terminate this agreement with immediate effect by delivering notice of the termination to the other party,

The other party fails to perform, has made or makes any inaccuracy in, or otherwise materially breaches, any of its obligations, covenants, or representations

6.2.2 The failure, inaccuracy, or breach continues for a period of 30 Business Days' after the injured party delivers notice to the breaching party reasonably detailing the breach.

Termination for Insolvency. If either party becomes insolvent, bankrupt, or enters receivership, dissolution, or liquidation, the other party may terminate this agreement with immediate effect
