MEMORANDUM OF UNDERSTANDING (MoU)

represented by the Proprietor hereinafter referred to as 'SAB'

The CCW and the SAB are also referred to individually as 'Party' and collectively as 'Parties'.

1. PURPOSE

The purpose of this Agreement is to define the basis for collaboration between CCW and SAB for Internship, Industrial Visit, Hands on Training programme, Organizing Seminar, Conferences and Workshops and Project Work of B.Sc., Microbiology and M.Sc., Microbiology Degree Programme.

Scope of the MoU will include but will not be limited to the following:

- a. Student Internship and Performance Assessment: SAB will accept limited number of students each year for internship for a duration of 15 days to train them in industrial processes. There will be no obligation on part of SAB to pay remuneration to the students at the time of internship or to guarantee them employment on completion of internship. CCW agrees to depute a faculty to monitor periodically the progress of students and ensure their disciplinary behavior, meeting with industry norms and regulations. SAB will carry out assessment of student's performance and provide an attendance cum performance review report and Internship completion certificate.
- b. Industrial visit: SAB will accept limited number of students from CCW each year for industrial visit to observe the functional areas of SAB such as Microbiology Laboratory and Biochemistry laboratory.
- c. **Project work:** SAB will allow students of CCW for data collection for project work. The data which will be provided by SAB can be primary or secondary data.

2. TERM AND TERMINATION

This MoU shall be valid for a period of 3 years from the Effective Date. Thereafter CCW and SAB may mutually agree to extend this MoU in writing.

Parties may terminate this MoU upon giving thirty (30) days written notice to the other Party for breach of any material provision of this MoU, and where there is failure to correct such breach within the said notice period.

. OTHER GENERAL TERMS

It is agreed between the Parties that this is an arrangement between both the Parties and shall not present to third parties that they are the agent of the other. Nothing in this MoU shall be construed to grant ther Party the right to make commitments of any kind for or on behalf of the other Party without prior written nsent of the other Party.

This MoU contains no representations or warranties, and the Parties specifically disclaim any and all ranties, express or implied, with regard to this MoU and the subject matter hereof.

All commercial, process, data and information shall be kept confidential by both the parties. Publication of any results in public domain shall only be after mutual written consent. Intellectual property rights arising from joint collaborative work shall be shared mutually based on prior agreement for specific projects.

This MoU shall be governed and construed in accordance with the laws of Republic of India.

Disputes, if any, arising out of this MoU will be mutually discussed and settled without any obligation on either Party, failing which, the disputes shall be referred to Arbitration of two Arbitrators, one each to be appointed by the Parties and a third Arbitrator shall be appointed by the two Arbitrators appointed by the Parties, who shall act as 'Presiding Arbitrator'. The Arbitration proceedings shall be in accordance with the provisions of Arbitration and Conciliation Act, 1996 and Rules framed there under from time to time. The place of Arbitration shall be at Tiruchirappalli and all Arbitration proceedings shall be conducted in English language and governed by the above said Act and Rules and in Indian Laws.
